Field Trips

Epiphany Early Learning children may take walking field trips around the neighborhood or to nearby locations such as the duck pond or Madrona Park. On occasion we may also take field trips to more distant parks or to other attractions such as the Children's Museum or Woodland Park Zoo. For these field trips we will use the Metro Bus system and we will notify you a few days ahead of time and ask you to sign a field trip form indicating that you are aware of the field trip and authorize your child to participate.

_____ I grant permission for my child to participate in walking field trips. This authorization is for walking field trips only. I understand that I will be asked to sign a separate field trip form when Epiphany Early Learning is going on a trip that requires transportation such as the Metro Bus system. I understand that staff will take a copy of the Emergency Contact List and Consent for Emergency Treatment Form that I filled out at the time of registration whenever they are off campus.

<u>Sunscreen</u>

State licensing requirements permit childcare facilities to apply sunscreen to children only with written consent from the parent/guardian. Please initial if you would like your child to use sunscreen while at Epiphany Early Learning. We provide both *Black Girl Sunscreen Kids SPF 50* and *Babyganics SPF 50 Sunscreen Lotion*. If you have a preference of which of these two you'd like us to use, please let us know. If would like your child to use a different brand all together, please supply it yourself, along with a completed medication form which can be found on our website. We recommend that all children use a sunscreen, and ask that the first application is done before dropping off at school. Please select one of the following:

Pet Policy

_____To insure children's health and safety, we follow state childcare licensing guidelines regarding pets. We currently are pet-free. If that changes, pets at Epiphany Early Learning Preschool will be kept in well-managed, clean cages and containers. Fish tanks will be maintained by parent volunteers or teachers and staff will make it part of their weekly routine to ensure that pets are well cared for and that the space is kept clean and free of germs. On the rare occasion that children touch animals, they are asked to wash their hands with soap and water immediately afterwards. We understand the desire to bring family pets into the classroom, however prior approval from the office must be obtained before doing so. Please leash your family pet safely away from where children play if your pet accompanies you when dropping off our picking up.
